

The **NSW Law Reform Commission** gives advice to the NSW government about changing the law.




We are looking into a law called the **Anti-Discrimination Act**.



The **Anti-Discrimination Act** is a law about how people must be treated in a fair way.

We will say **ADA** for short.



We want to find out if the government should make changes to the ADA.

About discrimination



The ADA tries to stop 2 kinds of discrimination from happening.



These are


1. When someone treats you in a bad way because of who you are.



2. Where there is one rule for everyone but it is unfair for some people.



There might be a rule everyone has to work in a building with no lift.



This would be unfair for someone who uses a wheelchair.


The ADA says discrimination should not happen because of things like

- Your disability




- If you are married or not

The ADA also says discrimination should not happen because you are


- **Gay**

Gay means men who have sexual feelings for other men.




Lesbian means women who have sexual feelings for other women.



Transgender means people who feel different from the sex they were born.

The ADA says discrimination should not happen in places like




- Work

- Where people pay to live like a group home




- When they are a member of a club.


Vilification



The ADA says **vilification** should not happen to some groups of people.




Vilification means when someone says or writes very bad things about someone else in public.



ADA says vilification is against the law if it is about being

- Gay
- Lesbian
- Transgender.



It also says vilification is against the law if it is about you having **HIV** or **AIDS**.



HIV and **AIDS** are blood diseases that can make people very sick.



The ADA does not say vilification is against the law if it is about

- Your disability
- If you are a carer for someone.



The ADA says it is vilification if a person does something in public that

- Tries to make others hate a person or group
- and
- Is for something about that person or group like their disability.

Sexual harassment




The ADA says **sexual harassment** is not allowed.



Sexual harassment is when someone

- Does sexual things to someone who does not want it
- Says sexual words to someone who does not want it.



When these things happen the person might feel

- Sad
- Scared
- Embarrassed.

The ADA says sexual harassment should not happen in places like

- Work
- Where people learn like school
- Where people get and buy things
- When someone pays to live somewhere
- When someone plays sport in a team.



The ADA does not say sexual harassment is against the law in all places.

What you can do if you are treated badly




If you are treated badly you can make a **complaint** to **Anti-Discrimination NSW**.



Complaint means you speak up about something bad that happened to you.



Anti-Discrimination NSW looks after all the complaints people make about the ADA.




Anti-Discrimination NSW can then try to support the people to see if they can fix the problem together.



NCAT
NSW Civil &
Administrative
Tribunal

If they can not fix the problem the complaint can go to the **NSW Civil and Administrative Tribunal**.

We will say **NCAT** for short.



NCAT helps to decide what to do about complaints when people do not agree.



They say there should be an organisation that helps to stop


- Discrimination

Some people say this organisation should keep groups of people safe.




Some people think bosses at jobs should need to do things in their workplace to stop
